INSTRUCTIONS FOR PREPARATION OF FULL PAPERS FOR THE 15th ASIAN-PACIFIC CORROSION CONTROL CONFERENCE (15th APCCC)

Abstract: This document contains guidelines for preparation of full papers to be presented at the 15th Asian-Pacific Corrosion Control Conference (15th APCCC) at Dusit Thani Hotel Manila, Philippines on October 18-21, 2009. The full papers will be included in the seminar proceedings. Authors are requested to submit full papers in MS Word format on or before August 15, 2009. (The abstract should be within 250-350 words.) This template can be used by the author to prepare his manuscript by replacing paragraphs and/or figures of the present file with the actual ones using CUT & PASTE commands.

1. FORMAT OF PAPER

Papers must take the following format:

- A4 paper (21 cm wide by 29 cm long)
- Upper, lower and right hand margins of 2.5 cm.
- Left hand margin of 3 cm.
- Font: Times New Roman
- Font Size: 12 point pitch
- Single spacing
- Maximum length of 10 pages, including figures, tables, appendices and references.
- Do not indent but leave a blank line between paragraphs.
- Page numbers should be printed on the bottom right of the page, font (10), italics.

The official language of the Seminar is English. All papers are to be submitted in English.

2. STRUCTURE

First page: This is an example of the first page of the full paper. The title of the paper should be centered in bold capitals. Each author's name (in bold), position and organization are placed and centered, as shown above. Each author's surname should be typed in capitals. If there are two authors, the second author's information should be placed under first author as described on this page.

After a blank line below the information on the author(s), an abstract of 250-350 words and five key words at most should be placed. Then, after two blank lines, the main body of the paper starts, which is divided in chapters and (optionally) sections. The paper may consist of **1. INTRODUCTION; 2. EXPERIMENTAL METHODS or METHODOLOGY; 3. RESULTS AND DISCUSSION; 4. CONCLUSIONS or SUMMARY; and REFERENCES.** Chapters must be numbered and their title typed in bold capitals (for example, **1. INTRODUCTION**). Sections must be numbered using two digits and their title typed in bold typeface (for example, **2.1 Model Validation**). Two blank lines must be left before each title of the chapter with the exception of new pages. One blank line must be left before the title of section or sub-section with the exception of new pages. All the text must start at the left hand margin (that is, new paragraphs are not to be indented) with the exception of listings, which may be indented.

The order of the paper is as follows:

- First: Title, authors' information and the chapters of the main body of the text, numbered as indicated above.
- Second: the **ACKNOWLEDGMENTS** (title centered and in bold capital typeface) if required.
- Third: the **REFERENCES** (title centered and in bold capital typeface)
- Fourth: appendices if necessary

3. EQUATIONS, TABLES AND FIGURES

3.1 Format of Tables

- Tables must be numbered sequentially and have a reasonably explanatory title centered over the table; the measurement units employed in the table must be indicated.

3.2 Format of Figures

- Figures must be drawn using good quality graphic software; they must be numbered

sequentially and have a reasonably informative title centered under the figure.

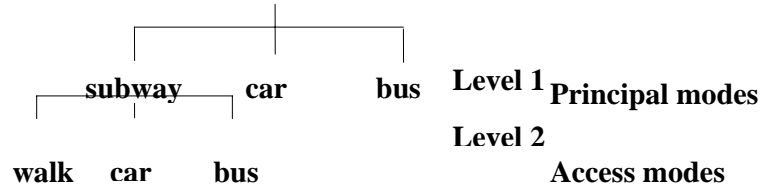


Figure 1. Choice Tree for Commuting Modes

3.3 Format of Equations

- Equations must be written preferably with the same word processor used for the rest of the text, without handwritten symbols in order to aid legibility. Equations must be numbered sequentially with their numbers in parenthesis and right justified. Symbols used in an equation should be defined immediately following the equation where first used. The sample format is shown below.

Example of Equation:

The estimate of the roadside pollutant concentration 3 meters from the edge of the road is given by:

$$C(x, z) = \frac{Q_L}{(2\pi)^{3/2} \gamma} \left\{ \frac{\pi}{\eta_1} + \frac{\pi}{\eta_2} \right\} \quad (1)$$

where $C(x, z)$: dispersed concentration at point (x, z) from the line source ($\mu\text{g}/\text{m}^3$)

x : distance from x coordinate axis of the emission source (m)

z : height from the ground surface (m)

Q : emission intensity of source ($\mu\text{g}/\text{m}/\text{s}$)

H_e : height of emission source (m)

α : horizontal direction dispersion coefficient (m/s)

γ : vertical direction dispersion coefficient (m/s)

$$\eta_1^2 = x^2 + \frac{\alpha^2}{\gamma^2} (z - H_e)^2, \eta_2^2 = x^2 + \frac{\alpha^2}{\gamma^2} (z + H_e)^2$$

v : speed (km/h)

5. FORMAT OF REFERENCING

The Harvard System of referencing must be used. In the body of the text papers or documents are referred to by author's surname with the year of publication in parenthesis; if the quotation is itself in parenthesis, the year of publication is separated by a comma. If the reference has more than two authors, only the surname and initials of the first author followed by *et al.* in italics will appear in the body of the text.

To complete the paper, references must be given alphabetically by author's surname including: surname(s) and initials of author(s), separated by a comma, year of publication in parenthesis, title of paper, title and volume of the journal in bold typeface, and first and last pages. In the case of books, the title of the book must be in bold typeface, with the first letter capital; the publisher and the city of publication must be indicated.

The following examples present some of the most typical cases of referencing at the end of the paper; please follow them as strictly as possible.
